In accordance with s.37 and s.37A of the RMA, an extension to the timeframe for issuing a request for further information on the Maitahi Bayview Private Plan Change request has been issued.

Council has considered the matters in relation to s 37A (1) and (2). The extension of time has been issued to discuss and clarify the further information matters with the applicant.

The RMA prescribes a 20 working day period to issue a further information request and this has been extended by a further 10 working days to 49 working days. You can now expect a request by 25 June 2021.
