

**THE NELSON RESOURCE MANAGEMENT PLAN  
PUBLIC NOTICE OF PROPOSED PLAN CHANGE  
21.5 (PARKING)  
(RE-NOTIFIED)**

**Clause 5 of First Schedule, Resource  
Management Act 1991 (RMA)**

Nelson City Council is re-notifying proposed Plan Change 21.5 to the Nelson Resource Management Plan (the proposal). When Plan Change 21 was notified on 25 September 2010, the section 32 table for part 5 of that Plan Change was absent from the accompanying section 32 report. Plan Change 21.5 is therefore void and is now re-notified with the missing section 32 table provided. Since there is a very long submission period for the plan changes, the closing date for submissions for the re-notified Plan Change 21.5 will remain 3 December. The other parts of Plan Change 21 are unaffected.

**WHAT THE PROPOSAL COVERS**

1. Amends the parking rule for the block bounded by Collingwood, Hardy, Harley, Malthouse Lane and Riverside so that the area is treated as if it is City Centre for parking purposes
2. Amends rule ICr.76 and the parking rules in other Zones to make it easier to apply for a reduction in mandatory parking if a travel management plan for the site is provided.

You are required to use the submission form provided, or a similar format consistent with Form 5, Resource Management (Forms, Fees & Procedures) Regulations 2003.

**THE PROCESS FOR PUBLIC PARTICIPATION**

The process for public participation in the consideration of the proposed Plan Change under the RMA is as follows:

- after the closing of submissions, Nelson City Council will prepare a summary of the submissions and this summary will be publicly notified, and
- there will be an opportunity to make a further submission in support of, or in opposition to, the submissions already made, and
- if a person making a submission asks to be heard in support of his or her submission, a hearing will be held, and
- Nelson City Council will make its decisions on the proposal (i.e. on the submissions and whether to amend the proposed Plan Change, including its reasons for accepting or rejecting submissions) within two years of this public notice, and any person who made a submission has the right to appeal the Council's decision on the proposed Plan Change to the Environment Court.
