Further to my email this morning asking you to refrain from sending emails and making social media posts on this matter I want to reconfirm my advice to you in that regard. It was agreed on Thursday that if there was any concern with a fellow councillor's conduct that I would make myself available to hear your concerns as opposed to the above. One councillor has taken up that offer and I appreciate that.

As an update, I have provided a response to the Nelson Mail as the Mayor. I have advised that I am reviewing the incident from a Council perspective. If this is a Police matter or likely to be then I can make no further comment at this time on any alleged assault. I have confirmed the advice I gave to elected members yesterday morning by email prior to the meeting, not to approach Civic House or engage with protestors. I have confirmed that I was comfortable with the way the Chief Executive and Police handled the matter and the way the protestors had cooperated. The media team were asked to provide a copy of the Code of Conduct which they have done. I have emphasized to the media that if elected members are concerned about the conduct of one of their colleagues then the Code of Conduct sets out the process to do this.

To be very clear that the Code of Conduct does not provide for elected members to undertake their own inquisitorial processes.

There has been a request to view the CCTV footage and I confirm that this is a matter for the Chief Executive and there are Privacy Act matters that must be taken into account. However, I can assure you that the footage will be saved.

My strong advice to you all is to allow a proper process to occur whether that is via the Police or our own Council processes.

I have confirmed the advice I gave to elected members yesterday morning by email prior to the meeting, not to approach Civic House or engage with protestors. I have confirmed that I was comfortable with the way the Chief Executive and Police handled the matter and the way the protestors had cooperated. The media team were asked to provide a copy of the Code of Conduct which they have done. I have emphasized to the media that if elected members are concerned about the conduct of one of their colleagues then the Code of Conduct sets out the process to do this.

To be very clear that the Code of Conduct does not provide for elected members to undertake their own inquisitorial processes.

There has been a request to view the CCTV footage and I confirm that this is a matter for the Chief Executive and there are Privacy Act matters that must be taken into account. However, I can assure you that the footage will be saved.

My strong advice to you all is to allow a proper process to occur whether that is via the Police or our own Council processes.
