OFFICIAL INFORMATION REQUEST FOR GREENMEADOWS REVIEW INFORMATION

I refer to your official information request dated 10 October 2019 for the following information about the Stoke Recreation Centre at Greenmeadows:

I recall seeing a statement some time ago that a report covering the failures encountered with the Greenmeadows Centre Project is being prepared. Would you please let me know when this likely to be released and confirm that I will be able to receive a copy.

We have considered your request in accordance with the Local Government Official Information and Meetings Act 1987 (**LGOIMA**) and respond as follows:

In August 2018, Council announced its support for a review external review on the management of large capital projects, undertaken by Nelson City Council. That review is intended to address the Stoke Recreation Centre.

The review has not yet started. This is because Council is currently seeking advice on the failures encountered at the Stoke Recreation Centre and options for recovery from third parties. It is not yet known how long this process will take as it depends on a number of factors.

Council intends to share information about the external review when it becomes available.

To the extent that your request seeks a copy of the external review report, this is declined under section 17(1)(3) of LGOIMA (on the basis the information sought does not exist).

To the extent that your request seeks clarification of the advice Council is currently seeking, this is withheld under section 7(2)(g) of LGOIMA (to maintain legal professional privilege).
