IF YOUR DOG(S) DIES DURING THE REGISTRATION YEAR, YOU ARE ELIGIBLE FOR A PARTIAL REFUND OF THE REGISTRATION FEE, AS OF THE DATE YOU APPLY IN WRITING TO THE COUNCIL

NOTE ON REGISTRATION FEES:

If you have already notified Council that your dog is neutered then a \$5 discount has already been applied to the fee for that dog. If you have not already notified your dog is neutered then we will need to see proof of neutering (vet certificate or similar). Once we are notified the discount will apply from the **next** registration year.

There is a reduced fee for being on Good Dog Owner status. To qualify as a Good Dog Owner you need to make application and meet set criteria in relation to fencing/control of your dog and have no proven complaints against your dog during the previous year.

For the purpose of the Dog Control Act 1996, you are the owner of a dog if –

- you own the dog; or
- you have the dog in your possession (otherwise than for a period not exceeding 72 hours for the purpose of preventing the dog causing injury, or damage, or distress, or for the sole purpose or restoring a lost dog to its owner); or
- you are the parent or guardian of a person under 16 who is the owner of the dog and who is a member of your household living with and dependent on you.
