OFFICIAL INFORMATION REQUEST FOR DETAILS AROUND NELSON MARKET LICENCE AREA AT MONTGOMERY SQUARE CAR PARK

I refer to your official information request dated 10 January 2024 for information regarding the contract held by Nita Knight in relation to the Saturday Market. The specific details requested were around the Licence area and any other regulations or bylaws that apply to the area outside the Licence. The information you requested is below and enclosed.

Please note that as part of the Licence to Occupy, Nelson City Council as Licensor requested that the raised paving area outside Bank Lane be closed to public vehicles during the hours of operation of the Market.

The plan attached shows the Licence area for the Market as outlined in red. The area outside of the Licence area is subject to the Traffic and Parking Bylaw 2023. The bylaw states that the car park spaces are to be utilised as designated, for example the parking spaces outside the Salvation Army store are to be used for motorbike parking only. The exception to this would be where car park spaces had been cordoned off as part of a traffic management plan.

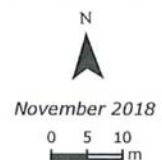
