



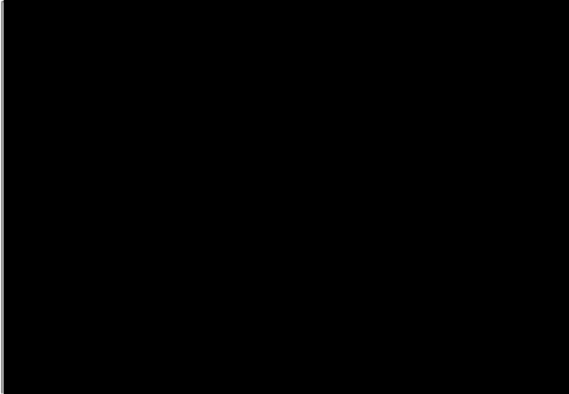

OFFICIAL INFORMATION REQUEST FOR ALCOHOL LICENSE COUNT

Thank you for your request for information received on 4 February 2025. Our responses follow each request below:

1. *"How many off-licences were operating in your territorial authority boundaries as at 31st December 2024 (if you cannot confirm at that specific date, how many off-licences do you currently have operating in your territorial authority boundaries? Please kindly confirm which date you have used)"*

There are 32 off-licences (on 7 February 2025).

2. *"Of these, please advise how many are endorsed under section 40 (i.e. remote sellers only)."*

Of the 32 off-licences, five are remote sellers.

3. *"We are interested in getting a sense of how many licensees are engaging in remote delivery, and while we understand that off-licences not endorsed under section 40 can start delivering remotely without notifying you, if you have any figures for off-licences that have delivered remotely in the last year we would appreciate seeing that as well."*

Council is aware of five off-licences delivering remotely.

4. *"How many on-licences were operating in your territorial authority boundaries as at 31st December 2024 (if you cannot confirm at that specific date, how many off-licences do you currently have operating in your territorial authority boundaries? Please kindly confirm which date you have used)."*

There are 100 on-licences operating (on 7 February 2025).

5. *"A copy of your most recent annual report to the Alcohol Regulatory & Licensing Authority (ARLA)."*
