FILLING STATION INFORMATION:

With the introduction of the Drinking Water Quality Assurance Rules 2022, there are some new rules which Council has been working toward implementing to achieve annual compliance.

In order for Council to comply with Rule D3.6, we are no longer permitted to allow access to draw water from the reticulation via fire hydrants with the exception of our Maintenance Contractor and Fire and Emergency New Zealand.

In order to allow contractors and other water users to still access water from the Council reticulation for bulk filling, dedicated tanker filling stations have been constructed.

The previous "Fire Hydrant Permit" will be replaced with the annual registration to access the filling station.

This will be an annual fee of \$247.20, regardless of the time of year access is applied for.

One access tag will be included free with your initial application.

Additional access tags will be available for a fee of \$61.80 each. This will be the same replacing lost or damaged tags.

This will roll over on 1 July each year and access to the filling station will be cancelled unless the user has reapplied. A reminder letter to all current users will be sent out mid-June.

The sites are automated with tag access, keypad volume selection, push button start and auto stop for the selected volume.

Water take will be measured automatically and assigned to the company/fob.

Water volume will be invoiced at the current "Urban Rate".

Invoices will be sent monthly, including a transaction list for the month to assist with cost distribution.

A phone number to use if assistance is required will be available at each site.

Please be patient as this is a new system and we may experience some teething issues.

WATER FILLING STATION USE PERMIT CONDITIONS:

Specific Conditions:

- 1 The provisions of the Nelson City Council Backflow Prevention Policy and current Water Supply Bylaw are to be complied with at all times. The full bylaw can be viewed on the Council's website: www.nelson.govt.nz
- 2 Water may only be taken from the Council specified filling stations at Nayland Road and Wildman Avenue. Contractors are no longer allowed to take water from hydrants using a standpipe.
- 3 Unless the permit holder is a registered water carrier, water taken under this permit may not be used for human consumption.
- 4 Nelson City Council will be invoicing the permit holder on a monthly or quarterly basis (depending on the expected duration of the project) for the cost of water taken as per the current urban water rates as published on the Nelson City Council website.
- 5 Permit conditions are subject to change at any time in order to meet the requirements of Taumata Arowai or any new central government legislation.
- 6 Other conditions specific to your intended water use may be put in place by Nelson City Council. This will be reviewed on a case by case basis.
- 7 Water conservation:
 - At all times water taken from filling stations should be the minimum required for the purpose intended.
 - During water restrictions Stage1 to Stage 3 conservation of water is essential with water taken to be for essential purposes only.
 - During Stage 4 restrictions water can only be taken from filling stations with express permission from Council.
 - Permit will be suspended during Stage 5 and Stage 6 restrictions.
